Second Quarter 2025

Market Review

The MSCI All Country World ex. U.S. Small Cap Index increased 16.93% in the second quarter 2025. During the first quarter, global markets were negatively impacted by uncertainty surrounding the Trump Administration's tariff and trade policy. While we still do not have clarity on how the tariff issue will be resolved, markets have concluded that some of the worst-case scenarios are unlikely, leading to a broad-based equity market rally in the second quarter. Inflation data during the quarter continued to bolster expectations for accommodative monetary policy in the coming months, which further boosted global stock and bond markets.

Portfolio Review

The International Small Cap portfolio underperformed the MSCI All Country World ex. U.S. Small Cap Index during the second quarter. We would typically expect our portfolio to underperform during sharp stock market rallies.

The top contributors to performance in the second quarter were Baltic Classifieds and AJ Bell.

- Listed in London, Baltic Classifieds operates several online classified portals across the Baltic states of Lithuania, Latvia, and Estonia. The company has been reporting solid business results, which we think contributed to the strong performance of the shares.
- AJ Bell operates an investment platform in the UK. The shares outperformed during the quarter as the company reported continued earnings growth and market share gains.
- Other top contributors in the quarter included Sopra Steria, Rightmove, and SHIFT.

The biggest detractors to performance during the quarter were MarkLines and Alten.

- MarkLines operates an information portal for the auto industry. The stock underperformed after 1Q earnings were impacted by weaker results at some of its adjacent, more cyclical business lines, such as consulting and vehicle benchmarking.
- Alten is a leading outsourced research and development engineering firm headquartered in France. Demand for outsourced engineering has been cyclically weak, and previously shared expectations for stabilization in demand did not materialize during the quarter.
- Other detractors in the quarter included Anhui Gujing Distillery, Haitian International, and CAE.

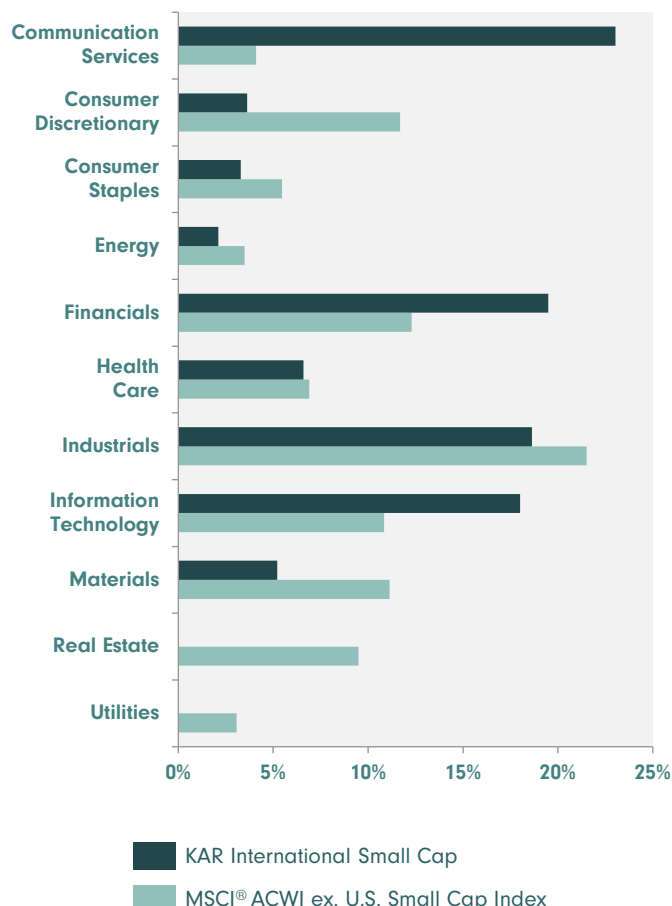

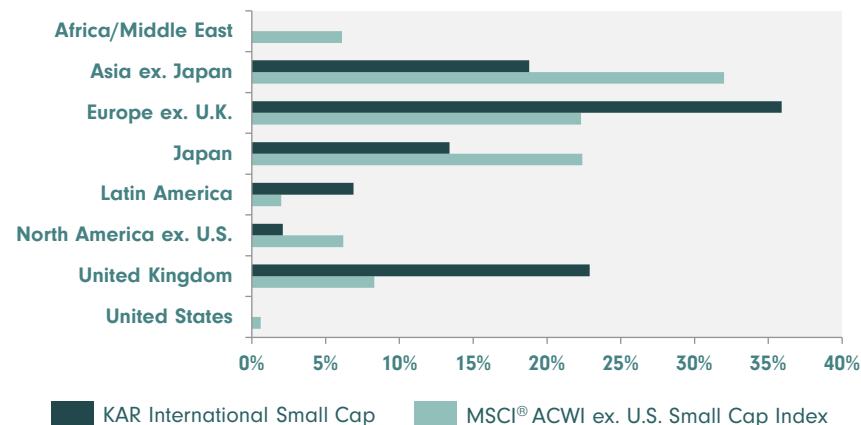
Developed vs. Emerging Markets

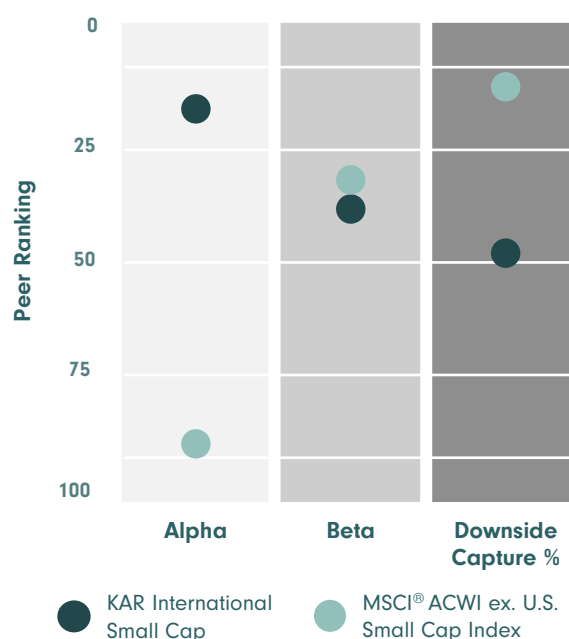

GLOSSARY

Alpha: A risk-adjusted measure of an investment's excess return relative to a benchmark. Upside Capture Ratio: A statistical measure of an investment manager's overall performance in up-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has risen. Sharpe Ratio: A risk-adjusted measure calculated using standard deviation and excess return to determine reward per unit of risk. Information Ratio: The information ratio (IR) is a measurement of portfolio returns beyond the returns of a benchmark, usually an index, compared to the volatility of those returns. Beta: A quantitative measure of the volatility, or systematic risk, of a security or a portfolio in comparison to the market as a whole. Downside Capture Ratio: A statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.
